DISTRICT DEMOGRAPHICS 2020 CENSUS DATA



- Validated redistricting data was released by the California Department of Finance on September 20.
- These data showed changes in the area served by Campbell Union School District (CUSD) from 2010 to 2020, including:
 - Overall population growth of 5,918 (6.3%)
 - Total Variance of 11.6% based on 2020 Census (*Out of Compliance*)
